

# Announcement of the State Administration for Market Regulation (CNCA) on Optimizing China Compulsory Product Certification (CCC) Catalogue

In April 2020, the State Administration for Market Regulation of P.R. China (CNCA) revised and published the "China Compulsory Certification (CCC) Catalogue Description and Definition Table". The new catalogue covers 107 products divided into 13 categories (see below list).

Category No.	CCC product range (not include self - declared products)
01	Electrical wires and cables
02	Circuit switches, electric devices for protection or connection
07	Household and similar electrical appliances
08	Electrical and electronic equipment within the field of audio, video, information and communication technology

Among these categories, there are 3 that have recently been added to the catalogue: *electrical apparatus for explosive atmospheres (23)* and *household gas appliances (24)* from October 1, 2019; and *car brake pads (1120)* from June 1, 2020. CCC is required before import these products into China.

And 19 products (see list below) that are applicable to compulsory product certification self-declaration evaluation methods. No more CCC will be issued to these products, but manufacturers need to submit the required documents to CNCA, and the CCC mark is still required on the product.

From November 1, 2020, The China Quality Certification Center (CQC) provides voluntary certification to products that are applicable to CCC self-declaration evaluation method. This certification simplifies the process of product changes and reduces the risk of customs clearance.
